Minutes of the meeting of Melbourne Parish Council held at 7.00pm on Monday 8 July 2019 in the Sports Pavilion, Melbourne.

Present: Councillors Tomalin (in the chair), Hawley, Johnson, Kemp, Breeze and Braidley and Rollason.

- **19/17** Apologies: Councillors Lee and Cooper.
- 19/18 Members of the public present: 0
- 19/19 Declarations of interest None
- 19/20 Minutes of the meetings held on 13 May 2019 Agreed that the minutes of the meetings be approved as a correct record and be signed by the Chairman.
- 19/21 Matters arising from minutes:
 - **18/141** Land North of Field View still waiting for this application to come to the Planning Committee. Cllr Rudd would update the Clerk when it was scheduled to be on the agenda. Cllr Rollason agreed to put an article on the village Facebook page and would organise any possible transport to the planning committee if there was an interest in this.
- **19/22 Weight restriction in the village** the Clerk had received an update from the Highways Authority. The formal advertisement would be published in the Pocklington Post, online and on site for a three week statutory period from 10 July.
- **19/23** Speeding through the village the issue of extending the 30mph and 40mph zones was discussed.
 - It was agreed that ClIr Lee ask Mr A Thelman to attend the September meeting of the Parish Council to discuss possible speeding restrictions in the village. In addition, the Clerk would contact East Riding of Yorkshire Council (ERYC) to request a site meeting with a representative from Highways to discuss:
 - a) the possibilities of extending the 30mph zone from The Shetlands to where the 40mph sign is positioned leaving the village to the east (just beyond the scout hut);
 - b) the current position of the 40mph sign to the east of the village;
- **19/24 Yorkshire Water** the Clerk was continuing to chase Yorkshire Water for an update on the work carried out in the parish.
- 19/25 Telephone box refurbishment Agreed that the Parish Council grant up to £300 to the book exchange group to complete the refurbishment of the phone box.
